## Introducing BUILD

BUILD stands for 'Biblical Understanding for In-service Leadership Development'. Most church leaders today serve in the growing churches of the non-Western world. Yet the majority have little or no training. In response, BUILD equips church leaders to build living churches that build God's kingdom. It does so with confidence in Christ's own commitment: "I will build my church".

BUILD grew out of the Church of Uganda's (COU) response to its own training needs. It delivers biblical, practical and theological education to those who need it most. It does so by training trainers to use a curriculum designed and developed in their local context, a multiplication model of training that means it can have an extensive impact. BUILD's wider potential was recognised as it developed and BUILD is now used by churches in similar contexts, particularly in East and Central Africa.

The research and writing of the BUILD curriculum is ultimately the work and responsibility of Rev Dr Jem Hovil with Canon Stephen Ssenyonjo Kewaza. However, the materials have strong local ownership. It is known that they capture and carry the perspectives and input of a range of groups and individuals in and around Uganda. They include those who came from Uganda, Rwanda, Tanzania and Kenya to attend the series of local participatory curriculum development workshops hosted by Uganda Martyrs Seminary, Namugongo between 2009 and 2014. Those workshops were based on earlier research and development, which included 573 responses to a questionnaire survey. That lengthy list of voices, listed on that website, is representative of the many at the grassroots who continue to use the materials and provide feedback for their constant revision.

### **1.2 THE WORD 'BUILD' AND A VERSE TO REMEMBER**

- Can you think of any verses in the New Testament where the word 'BUILD' or the idea of building is used when talking about the church?
- What do these verses teach and why is the word 'build' so important in the New Testament?

Your Trainer or Local Facilitator will guide you in your thinking and give you a verse to memorise and explain.

### **1.3 THE MEANING OF THE LETTERS B U I L D**

Not only does the name 'BUILD' have a meaning, but each letter in that name also stands for something. They have been linked to verses from 2 Timothy in order to make it easier for you to learn about the programme, and because 2 Timothy is the first book that the BUILD programme looks at, here in Module One.

- Take a look at the letters, the words they represent and the Bible verses by them.
- Why have those verses been chosen? Try and explain the connection between the word (for example 'Biblical') and the verse (for example 2 Tim 3:16-17). What do they tell us about sound pastor training work?

<b>B</b> is for <b>Biblical</b> ...	2 Tim 3:16-17	"All Scripture..."
<b>U</b> is for <b>Understanding</b> ...	2 Tim 2:15	"Correctly handles..."
<b>I</b> is for <b>In-service</b> ...	2 Tim 1:8	"Testify..."
<b>L</b> is for <b>Leadership</b> ...	2 Tim 2:2	"Entrust to reliable men..."
<b>D</b> is for <b>Development</b> ...	2 Tim 3:14	"Continue..."

In summary, the name 'BUILD' stands for:

**'Biblical Understanding for In-service Leadership Development'**

#### **1.4 FIVE CHALLENGES WE FACE**

Following on from the above we can underline the importance of BUILD in terms of five challenges we face in local church leadership:

**1. Biblical** – “All Scripture...”

The challenge of keeping the Bible central

**2. Understanding** – “Correctly handle...”

The challenge of explaining and applying the teaching of the Bible

**3. In-service** – “Testify...”

The challenge of remaining committed to mission

**4. Leadership** – “Entrust...”

The challenge of a lack of faithful leaders who can train other leaders

**5. Development** – “Continue...”

The challenge of persevering with gospel ministry

- In what ways do any of the above challenges affect you and your work?
- Are there other challenges you are facing as a pastor or in training others?
- How can we begin to address and overcome these challenges together?

#### **1.5 THE MISSION, VISION AND STRUCTURE OF A BUILD PROGRAMME**

BUILD is designed to address the challenges we have discussed. Any BUILD programme, including the one that you are a part of, has a mission, vision and structure that serves the development of healthy churches through training leaders.

##### **1.5.1 BUILD’s mission and vision**

BUILD’s combined mission and vision statement:

BUILD’s mission is to equip grassroots pastors and leaders with a practical understanding of Scripture and theology, and to see lives, churches and communities transformed by the power of the gospel.

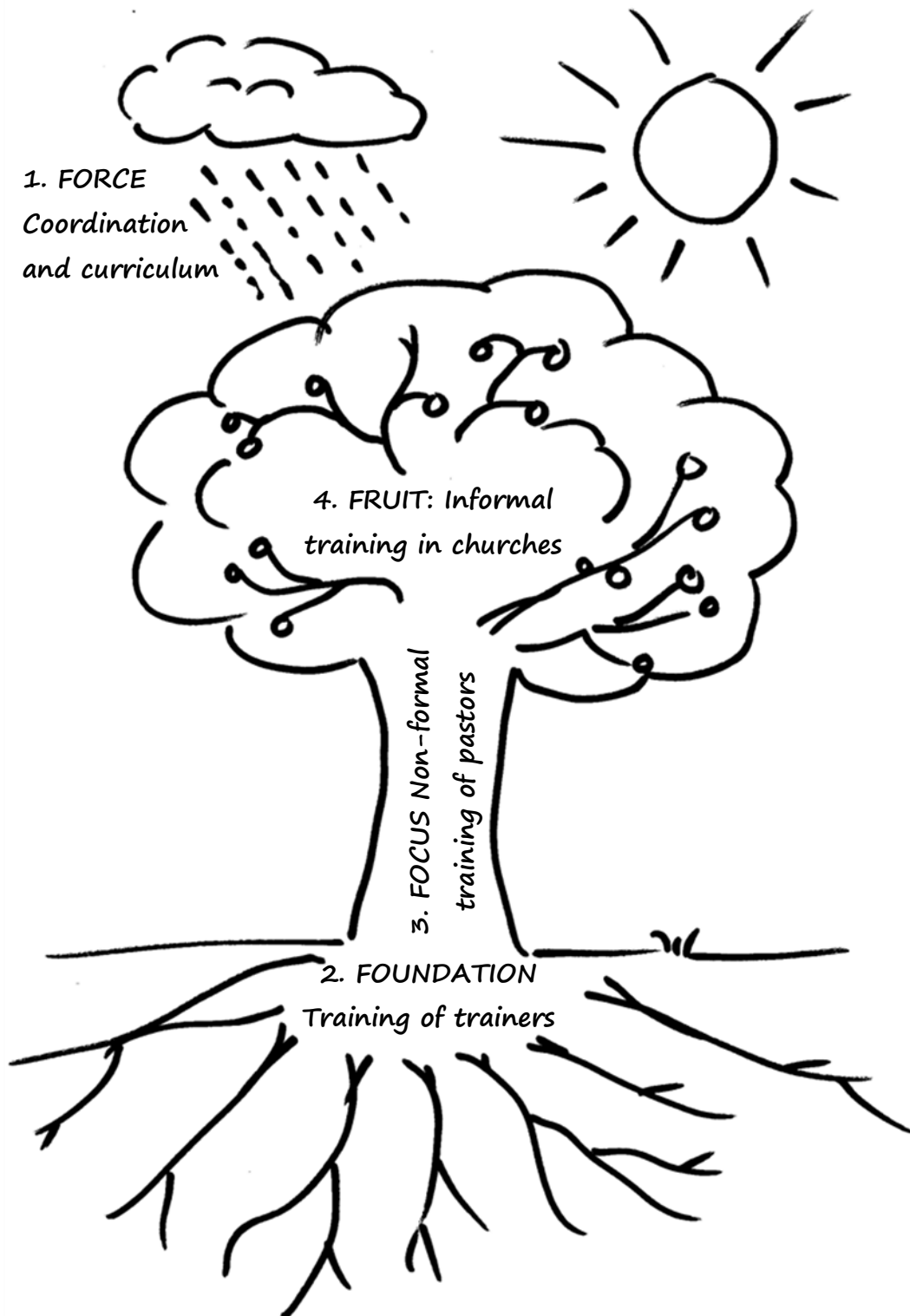
BUILD programmes vary from place to place, but there is an underlying structure that is designed to serve that mission and vision. We will now have a look at that structure so you can see where you belong and how you can benefit and contribute. We will begin by picturing it as a tree.

**1.5.2 The BUILD programme – pictured as a tree**

A picture of a healthy tree, with deep roots, a strong trunk and fruitful, shady branches is a good way of thinking about the BUILD programme. It might be a mango tree it provides shade and fruit and is central in many communities. Your Local Facilitator or Trainer will explain this picture to you.

#### 1.5.3 The BUILD programme – four areas of activity and impact

A more detailed description of a BUILD programme is given below. Your facilitator will decide whether to explain some or all of it to you now, or to return to it later.

##### 1. Programme coordination and curriculum development

*This is the FORCE behind BUILD – ensuring organisation and growth*

**Programme coordination** and **curriculum development** are essential for the health of the BUILD programme, so that it is well managed and resourced.

BUILD coordinators, trainers and local facilitators work in this capacity in different ways, but the **coordinators** lead this work of oversight.

##### 2. Formal training-of-trainers

*This is the FOUNDATION of BUILD – training leaders to train others*

Formal training-of-trainers is designed to produce well equipped **trainers** for the programme. This is sometimes done in partnership with colleges, training projects or networks of churches.

These trainers then train participants and local facilitators in local BUILD initiatives. In the process they are directly equipped for more effective ministry.

##### 3. Non-formal training of participants and local facilitators

*This is the FOCUS of BUILD – equipping grassroots pastors to serve*

Non-formal BUILD training is done in the setting of a **local BUILD group**. The **participants** are grassroots pastors and church leaders – the target group of the BUILD programme – who are encouraged in and equipped for ministry.

These groups are at the heart of the programme. They follow the BUILD curriculum and recognition takes place at the appropriate local level.

These groups are led by those who have been formally trained as trainers, or by **local facilitators**. Local facilitators are promising participants who have received further training from the trainers – they emerge to help strengthen and multiply these local groups.

##### 4. Informal training of other local church leaders and members

*This is the FRUIT of BUILD – transforming leaders, churches and communities*

An important outcome is the **informal training** that is encouraged through relationships at the local level. Those who have participated in the non-formal training encourage others. They might use BUILD materials or simply the BUILD principles. They might have group meetings or mentor individuals.

Lives, churches and communities are transformed by the training, with a wide variety of impacts as the gospel is proclaimed in word and deed.

Look back through the above description and discuss it with the Trainer or Local Facilitator and others in the group. Make sure you understand how the programme works.

If you are a Participant or Local Facilitator you fit into box 2: the 'Non-formal training of Participants and Local Facilitators', which is the heart of the initiative.

### **1.6 INTRODUCING THE BUILD CURRICULUM**

Don't worry if you do not cover this fully. It is a reference point for the whole curriculum. Your Trainer or Local Facilitator will introduce it and you can return to it.

A curriculum is a way, a path, for getting from one place to the next. From current attitudes, skills and knowledge to a new level that will help churches to grow.

#### **1.6.1 The 10 training modules in the BUILD curriculum**

The BUILD curriculum is made up of the following 10 modules:

<b>Module Eight</b>	<b>Proverbs and the Wisdom Books: The Fear of the Lord and Practical Leadership</b>

#### **1.6.2 Each module has four main components**

You may have noticed in the titles above that each module has four main components:

## BUILD MODULE ONE

1. **A book of the Bible**, that gives a focus. For example 2 Timothy in the case of Module One.
2. **A group of Bible books** or a type of writing, which the book is linked to. Module One looks at The Pastoral Epistles (1 and 2 Timothy and Titus).
3. **A theme** that is central to both the book and to pastoral leadership. Module One takes 'Understanding the Gospel' as its theme.
4. **A leadership issue** that flows out of that book and theme. 'Godly Leadership' is the issue for Module One.

This gives the following summary for Module One:

Unit 10 explains how and why the Bible books and groups of books are arranged in the curriculum in the way that they are.

#### 1.6.3 Each module has fifteen learning units and they are of four types

The modules use four types of learning unit:

1. **Tools** for encountering God's word in God's world. These build knowledge and skills for handling the Bible. They give practical tools and insights to help you to learn to understand and apply the Bible in your context.
2. **Encounters** with God's word in God's world. These put the tools to work as you look at passages of Scripture, as they appear in the Bible, and not only discover the structure and meaning of those passages, but also think through how to teach them to others. This movement from passage to people is important to BUILD.
3. **Reflection** for wisdom. These teach people to think for themselves and in groups about different issues, and to be able to lead others in this process. This type of unit teaches and develops skills of theological reflection.
4. **Action** as leaders in mission. These provide practical training in areas that are essential for local church leaders.

These four types of learning unit feature in the contents of Module One, which your facilitator will take you through now so that you can see the links.

All 150 units of the BUILD curriculum can be found at the end of this module, so that you can see everything that is covered and how it all fits together.
